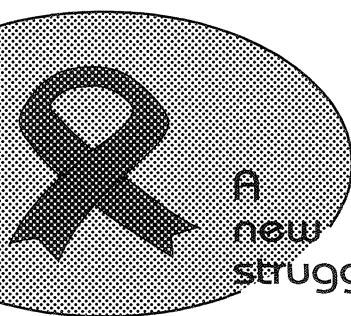

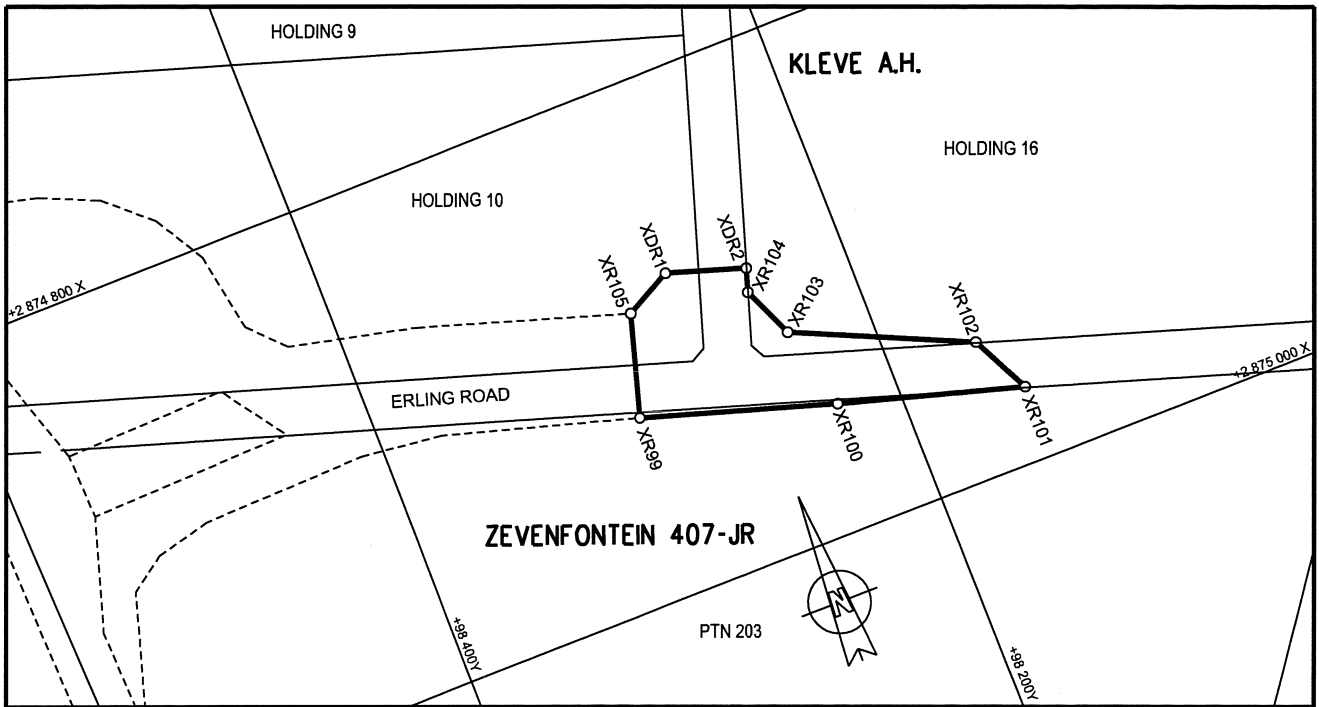
PROCLAMATION OF AN ACCESS ROAD IN CONNECTION WITH PROVINCIAL ROAD K46: DISTRICT RANDBURG

In terms of section 13(1) of the Gauteng Transport Infrastructure Act, 2001 (Act No. 8 of 2001) ("the Act") the MEC proclaims that an access road exist on Portion 203 of the farm Zevenfontein 407 JR, Holdings 10 and 16 of Kleve agricultural holdings, as indicated on the accompanying sketch plan.

In terms of section 23(6) of the aforementioned act, it is hereby declared that boundary beacons demarcating the said access road, have been placed and that plan GRP 12/13/1 Exp indicating the land encroached upon by virtue of the proclamation of the access road, is available for inspection by any interested person in the Plan Room of the Department of Roads and Transport, Sage Life Building, 41 Simmonds Street, Johannesburg.

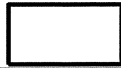
