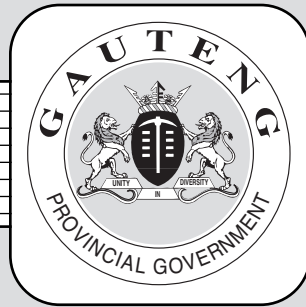

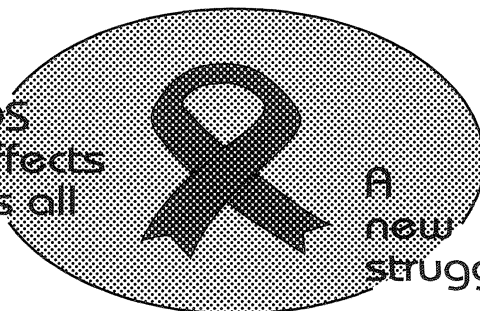

### NOTICE 2679 OF 2013

#### RANDVAAL AMENDMENT SCHEME 180

Notice of application for the amendment of the Randvaal Town Planning Scheme, 1994 in terms of Section 56(1)(b)(i) of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986).

I, Gavin Ashley Edwards, of GE Town Planning Consultancy CC, being the authorised agent of the owners of Erf 244 Graceview Extension 3 ("the property") hereby give notice in terms of Section 56(1)(b)(i) of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986) that we have applied for the amendment of the Randvaal Town Planning Scheme, 1994 by the rezoning of a part of the property described above, located to the west of the R59 / P156 Provincial Roadway, south of this roadways interchange with the R550 Provincial Roadway, in the township of Graceview Extension 3 from "Commercial" subject to certain conditions to "Special" for commercial, offices and industrial purposes, conference facilities, shops and special uses as set out in the relevant application documents, including ancillary, subordinate and related uses subject to certain conditions.

Particulars of the application will be available for inspection during normal office hours at the office of the Executive Director: Development Planning and Housing, Civic Centre, Mitchell Street, Meyerton for a period of 28 days from 2 October 2013.
