#### **GAUTENG REMOVAL OF RESTRICTIONS ACT, 1996 (ACT 3 OF 1996): PORTION 2 OF ERF 187 KLIPRIVIER TOWNSHIP**

It is hereby notified in terms of section 7(16) of the Gauteng Removal of Restrictions Act, 1996, that the Minister has approved that -

1. Conditions 2(g), 2(h) and 2(i) in Deed of Transfer T127416/2005 be removed.
2. Meyerton Town-Planning Scheme, 1986, be amended by the rezoning of Portion 2 of Erf 187 Kliprivier to "Commercial" which amendment scheme will be known as Meyerton Amendment Scheme H248 as indicated on the relevant Map 3 and scheme clauses which are open for inspection at the office of the ED: Development, Planning and Housing, Midvaal Local Municipality, Mitchelle Street, Meyerton.
