Reasons for the merger and closure of public ordinary schools.

- Natural attrition, as a result of the progressive decline in learner enrolment during the past 3 – 4 years which has challenged the effectiveness of curriculum provisioning, leading to problems of fewer educators, who are forced to resort to multi – grade teaching.




