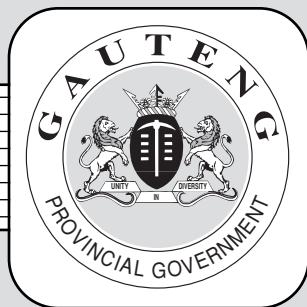

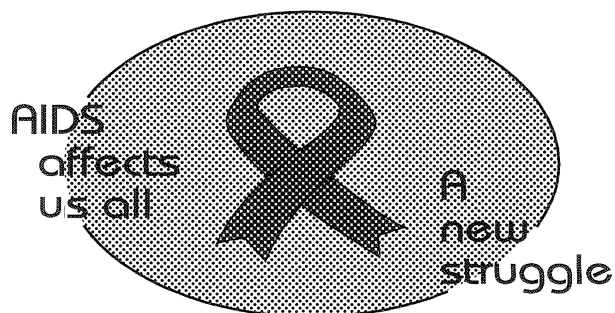

Notice is hereby given that GoldenTree Asset Management Lux SARL of 26 Boulevard Royal, L-2449, Luxembourg intends to submit an application to the Gauteng Gambling Board for consent to hold an interest as contemplated in Section 38 of the Gauteng Gambling Act, 1995, as amended, in Peermont Global (Pty) Ltd.
