

SETTLEMENT AGREEMENT

WHEREAS the Complainant entered into a contract for the Respondent to design and host a website for the Complainant entitled Portuguesenet.co.za on or about April 2011 for the amount of R13 400,00 (thirteen thousand four hundred rand). At all material times herein the Respondent was represented by Mr Adil Benkina, the managing director of the Respondent;

AND WHEREAS the Complainant paid a deposit of R5 320,00 (five thousand three hundred and twenty rand) of the total amount of R13 400,00 (thirteen thousand four hundred rand) as per the invoice, to the Respondent;

AND WHEREAS the Respondent completed the design of the website;

AND WHEREAS the Complainant has not yet paid the balance of the contract price;

AND WHEREAS the Complainant lodged a complaint against the Respondent with the Gauteng Office of Consumer Affairs;

AND WHEREAS the Consumer Protector has now entered into negotiations with the Complainant and the Respondent and has concluded an arrangement;

AND WHEREAS this arrangement / settlement subject to the Gauteng Consumer Affairs Court confirming it has the effect of an order of the Court by publication in the Gauteng Provincial Government Gazette;

THEREFORE THE PARTIES CONCLUDE THE FOLLOWING SUBJECT TO CONFIRMATION BY THE COURT IN TERMS OF SECTION 21 OF THE ACT AND AGREE AS FOLLOWS:

- The Complainant will pay the balance of the contract price of R8 080,00 (eight thousand and eighty rand) less R300,00 (three hundred rand) commission due to the Complainant which amounts to R7 780 (seven thousand seven hundred and eighty rand) in full and final settlement.
- The aforesaid amount is payable in monthly instalments of R2 000,00 (two thousand rand) with payment commencing on 31 January 2013 and thereafter on or before the last day of each succeeding month until the amount is paid in full. The Complainant will make each payment directly into the bank account of the Respondent, the details of which are as follows:

- Should payment not be done on any due date, the full balance will become due and payable immediately.
- 4. The parties agree that there will be no interest payable on the capital amount.

The website will be hosted by a provider of the Complainant's choice. The Complainant will provide the Respondent with the provider's credentials in order to effect the uploading of the website.
- 6. Once the website has been uploaded the Respondent loses all control of sald site and cannot be held liable for the functionality of the website nor is able to effect any changes or alterations on the said site.

INVITATION FOR THE NOMINATION OF MEMBERS OF THE GAUTENG CONSUMER AFFAIRS COURT

In terms of section 14 of the Consumer Affairs (Unfair Business Practices Act, 1996 (Act No 7 of 1996), the member of the Executive Council responsible for Economic Development hereby calls for nominations for members to serve in the Consumer Affairs Court.

- (i) All interested persons are hereby invited to submit their written nominations for appointment of members to the Consumer Affairs Court.
- (ii) Members of the court will be appointed by the responsible Member of the Executive Council in concurrence with the standing Committee of Economic Affairs.
- (iii) The court will consist of five persons, namely a Chairperson, who will be a retired judge of the Supremo Court; or an attorney, advocate, retired magistrate or lecturer in law at a university, with no less than ten years' cumulative experience in one or more such capacities; four additional members having special knowledge of or experience in consumer advocacy, economics, industry or commerce.
- (iv) No persons will be appointed or remain a member of the court if he or she is not a fit and proper person or:
 - · is not a citizen of the Republic resident in the Province
 - · Is a public servant
 - At the relevant time is, or during the preceding twelve months was, an officebearer employee of any party, movement, organisation or body of a party with a political nature
 - · Is an unrehabilitated insolvent
 - Has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under this Act or the Corruption Act, 1992 (Act No 94 of 1992), or any offence involving dishonesty
 - Has at any time been removed from an office of trust on account of misconduct
- (v) The nominees must include the following information:
 - Full name of the nominee
 - · A certifled copy of the nominee's Identity Document
 - · A certified copy of the nominee's qualifications
 - · A detailed Curriculum Vitae of the nominee
 - Motivation for the nomination
 - · A letter from the nominee accepting to serve as a member of the Court

A person may nominate himself or herself. Nominations should be submitted within 21 days after the date of publication to the Acting HoD, Mr Albert Chanee, Department of Economic Development, Private Bag X091, Marshalltown 2107.
