### NOTICE 2595 OF 2014

# CALL FOR NOMINATIONS OF CANDIDATES TO SERVE AS MEMBERS OF THE GAUTENG ENTERPRISE PROPELLER BOARD

- I. The Member of the Executive Council responsible for Economic Development in Gauteng Province hereby calls for nominations in terms of Section 7 (2) of the Gauteng Enterprise Propeller Act, Act No. 5 of 2005 of candidates to serve on the Gauteng Enterprise Propeller Board.
- II. All interested persons are hereby invited to submit their written nominations for appointment as members of Gauteng Enterprise Propeller Board;
- III. Members of the Gauteng Enterprise Propeller Board are appointed by the responsible Member of Executive Council;
- IV. The Board shall consist of no less than four and not more than 12 members;
- V. The Board must represent a broad section of the population of Gauteng with special attention to race, gender, disability, geographical spread and organizations based in rural areas;
- VI. The members of the Board should have experience or training in business; trade industry; finance or the economy; the legal framework applicable to small enterprises and the management of small enterprises;
- VII. No person shall be appointed a member of the Board if that person:
  - a) is not a citizen of the Republic, and resident in the Province;
  - b) is a Member of Parliament, a Provincial Legislature, a Municipal Council or a House of Traditional leaders established in terms of the Constitution;
  - c) is an unrehabilitated insolvent;
  - d) is of unsound mind, as declared by a competent court;
  - e) has at any time been convicted of an offence involving dishonesty;
  - f) has at any time been removed from an office of trust on account of misconduct; and
  - g) has previously been removed from the Board for a breach of any provision of this Act.
- VIII. The nomination must include the following information:
  - a) The full names of the nominee;
  - b) Motivation for the nominee;
  - c) A certified copy of the nominee's identity document;
  - d) Certified copies of the nominee's qualification/s;
  - e) Comprehensive CV of the nominee; and
  - f) A letter of consent from the nominee to serve as a Board member;
- IX. A person may nominate himself or herself.

The closing date for the nominations is **12 September 2014**.

*Applications of nominees received after the closing date will not be considered.*
