NOTICE 2804 OF 2014

CALL FOR NOMINATIONS OF CANDIDATES TO SERVE AS MEMBERS OF THE GAUTENG TOURISM BOARD

- I. The Member of the Executive Council responsible for Economic Development in Gauteng Province hereby calls for nominations in terms of Section 5A(2) of the Gauteng Tourism Act, Act No. 10 of 2001 as amended by the Gauteng Tourism Amendment Act, Act No. 3 of 2006 of candidates to serve on the Gauteng Tourism Authority Board;
- II. All interested persons are hereby invited to submit their written nominations for appointment as members of Gauteng Tourism Authority Board;
- III. The MEC must constitute and appoint a Board of not less than seven (7) and not more than ten (10) members including:
 - Officials from the Metropolitan Municipalities in the Province;
 - Officials from the District Municipalities in the Province; and
 - The Head of Department or his or her nominee.
- IV. The Board must be broadly representative of the population of the Province;
- V. Members serving on the Board must have sufficient knowledge, experience or qualifications relating to tourism in the Province and the responsibilities of the Board;
- VI. No person shall be appointed a member of the Board if that person:
 - a) is an unrehabilitated insolvent;
 - b) is convicted of an offence and has been sentenced to imprisonment without the option of a fine;
 - c) has, as a result of improper conduct, been removed from an office of trust; or
 - d) has been declared by a court to be mentally ill or disordered.
- VII. The nomination must include the following information:
 - a) The full names of the nominee;
 - b) Motivation for the nominee;
 - c) A certified copy of the nominee's identity document;
 - d) Certified copies of the nominee's qualification/s;
 - e) Comprehensive CV of the nominee; and
 - f) A letter of consent from the nominee to serve as a Board member.
- VIII. A person may nominate himself or herself;
- IX. Only persons residing in the Province of Gauteng should apply;
- X. Members of the Board hold office for a period not exceeding three years and are eligible for reappointment.

The closing date for the nominations is **11 September 2014**.

Applications of nominees received after the closing date will not be considered.
