

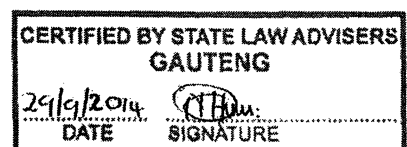

**SCHEDULE**

**Definition**

1. 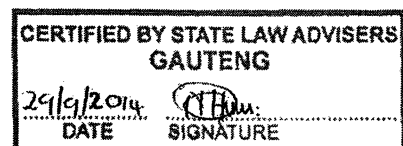

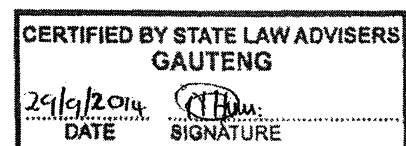
