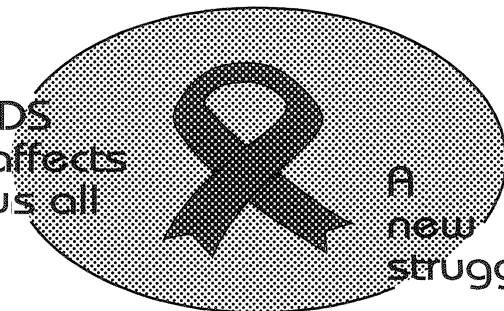

## GENERAL NOTICE

### NOTICE 4053 OF 2014

**NOTICE IN TERMS OF SECTION 12 OF THE LOCAL GOVERNMENT: MUNICIPAL SYSTEMS ACT, 2000 (ACT 32 OF 2000), ON WARD COMMITTEES OF THE CITY OF TSHWANE METROPOLITAN MUNICIPALITY ESTABLISHED IN TERMS OF SECTION 73 OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT 117 OF 1998) READ WITH SECTION 7 OF THE RATIONALIZATION ACT 10 OF 1998**

The City of Tshwane Metropolitan Municipality (herein after referred to as the "City of Tshwane"), pursuant to a resolution adopted on **25 September 2014** hereby gives notice, in terms of Section 12(3) of the Local Government. Municipal Systems Act, 2000 (Act 32 of 2000), as amended, read together with Sections 7 of the Gauteng Rationalization of Local Government Affairs Act, 1998 (Act 10 of 1998), and 162 of the Constitution of the Republic of South Africa, 1996 of its' intention to make By-laws in respect of the establishment of Ward Committees of the City of Tshwane in terms of section 73 of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998).

The purpose of the proposed By-law will be to make regulations in respect of the rules, procedures of establishment, composition, representativeness, functioning and matters incidental to Ward Committees and to repeal the By-laws on the Public Participation: Ward Committees, Petitions, Public Meetings and Hearings as published under Local Authority Notice 127 in Provincial Gazette Extraordinary, No 21 dated 1 February 2012 and policies pursuant thereto.
