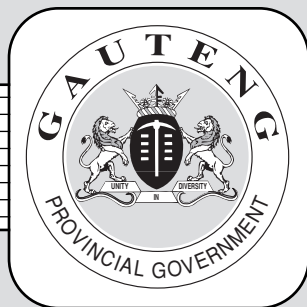

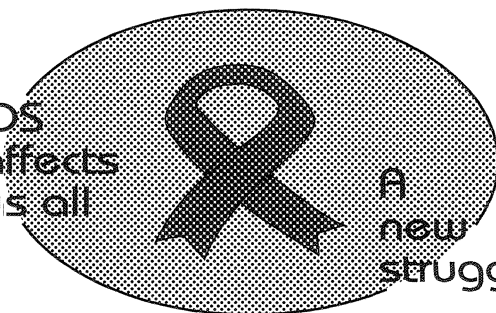

**NOTICE IN TERMS OF SECTION 20 OF THE GAUTENG GAMBLING BOARD
ACT 4 OF 1995 AS AMENDED**

NOTICE TO AMEND TOTE LICENCE AND ESTABLISH NEW OUTLET

Notice is hereby given that Phumelela Gaming and Leisure Limited intends to submit the application to the Gauteng Gambling Board for the amendment of a Totalizator licence to establish a new outlet at Shops 14 to 18, ERF 2228, Cnr Maredi & Moilwa Street, Moletsane (TAB Tsele's Centre).

The application will be open for public viewing at the offices of the Board from 26 February 2014.

Attention is directed to the provisions of section 20(2) (a) (b) (i)(ii) of the Gauteng Gambling Act No 4, 1995 which makes provision for the lodging of written representations in respect of the application.

Such representations should be lodged with the Acting Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018 or 125 Corlett Drive, Bramley, Johannesburg within one month from 26 February 2014.

Any persons submitting representations should state in such documentation whether or not they wish to make oral representations at the hearing of the application.
