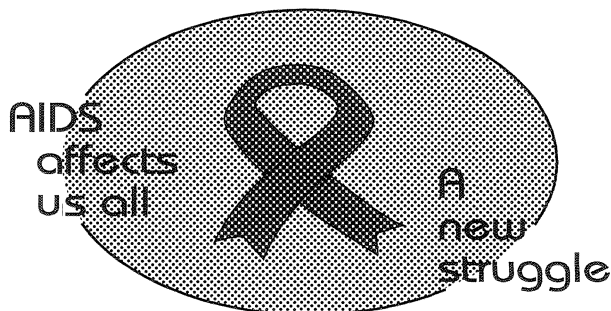

LIQUOR LICENCE VERIFICATION

The Gauteng Liquor Board has released a list of about 6148 liquor licenses, which may not be valid to trade in alcohol for various reasons.
