

# **DECLARATION AS APPROVED TOWNSHIP**

In terms of Section 103 of the Town Planning and Townships Ordinance, 15 of 1986, the Ekurhuleni Metropolitan Municipality hereby declares Bardene Extension 76 Township to be an approved township subject to the conditions set out in the schedule hereto.

# **SCHEDULE**

STATEMENT OF THE CONDITIONS UNDER WHICH THE APPLICATION MADE BY RAMAPITSI FAMILY TRUST REGISTRATION NO IT2389/2009 (J) (HEREAFTER REFERRED TO AS THE APPLICANT/ TOWNSHIP OWNERS) UNDER THE PROVISIONS OF SECTION C OF CHAPTER III OF THE TOWN PLANNING AND TOWNSHIPS ORDINANCE 1986, (ORDINANCE 15 OF 1986), FOR PERMISSION TO ESTABLISH A TOWNSHIP ON PORTION 1015 (A PORTION OF PORTION 158) OF THE FARM KLIPFONTEIN NO 83-IR HAS BEEN GRANTED BY THE EKURHULENI METROPOLITAN MUNICIPALITY

# CONDITIONS OF ESTABLISHMENT

# (a) NAME

The name of the township shall be Bardene Extension 76 Township.

# (b) DESIGN

The township shall consist of erven and streets as indicated on the General Plan SG No. 7909/2008.

# (c) DISPOSAL OF EXISTING CONDITIONS OF TITLE

All erven shall be made subject to existing conditions of title and servitudes, if any, including the reservation of rights to minerals.

# (d) DEMOLITION OF BUILDINGS AND STRUCTURES

The township owners shall at their own expense cause all existing buildings and structures situated within the building line reserves, side spaces or over common boundaries to be demolished to the satisfaction of the local authority, within a period of six (6) months from the date of publication of this notice.

# (e) REMOVAL OR REPLACEMENT OF MUNICIPAL SERVICES

If, by reason of the establishment of the township, it becomes necessary to remove or replace any existing municipal services, the cost thereof shall be borne by the township owners.

# (f) OBLIGATIONS IN REGARD TO ENGINEERING SERVICES

The township owners shall within such period as the local authority may determine, fulfil their obligations in respect of the provision and installation of engineering services as previously agreed upon between the township owner and the local authority.

# (g) ACCESS

A line of no access shall be applicable all along the proposed alignment of Elizabeth Road.

# (h) CONSOLIDATION OF ERVEN

Erven 1289 & 1290 shall be consolidated to the satisfaction of the Local Authority within 6 (six) months from the date of publication of the notice declaring the township an approved township.

# 2. CONDITIONS OF TITLE

The erven shall be subject to the following conditions imposed by the local authority in terms of the provisions of the Town Planning and Townships Ordinance, 1986:-

- (a) ALL ERVEN
- (i) The erf is subject to a servitude, 2m wide, in favour of the local authority for sewerage and other municipal purposes, along any two boundaries other than a street boundary, provided that the local authority may dispense with any such servitude.
- (ii) No building or other structure shall be erected within the aforesaid servitude area and no large-rooted trees shall be planted within the area of such servitude or within 2m thereof.
- (iii) The local authority shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude such material as may be excavated by it during the course of the construction, maintenance or removal of such sewerage mains and other works on it, in its discretion, may deem necessary, and shall further be entitled to reasonable access to the said land for aforesaid purpose, subject to any damage done during the process of the construction, maintenance or removal of such sewerage mains and other works being made good by the local authority.
- (iv) The township is subject to aircraft noise and neither Ekurhuleni Local Authority nor Airports Company South Africa Ltd can be held responsible for the negative impact of aircraft noise that could jeopardize the township.

# **EKURHULENI AMENDMENT SCHEME F0067**
