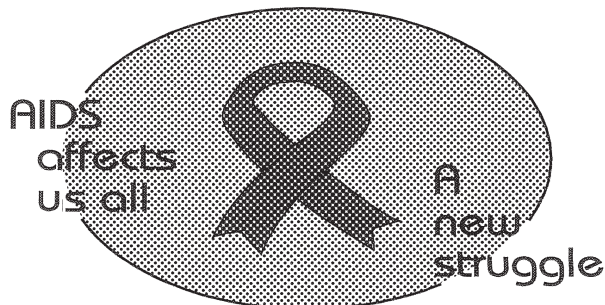

**NOTICE 2465 OF 2015****APPLICATION FOR AMENDMENT OF LICENCE CONTEMPLATED IN SECTION 34 OF THE GAUTENG GAMBLING ACT, 1995**

Notice is hereby given that Peermont Global Proprietary Limited trading as Emperors Palace of 64 Jones Road Kempton Park, intends submitting an application to the Gauteng Gambling Board ("**the Board**") for consent to amend Schedules B of its casino licence as contemplated in section 34 of the Gauteng Gambling Act, 1995 ("**the Act**"), so as to increase the maximum number of gaming positions that may be exposed for play by an additional 90 gaming positions.

The application will be open to public inspection at the office of the Board as from the 31 July 2015.

Attention is directed to the provisions of section 20 of the Act, which makes provision for the lodging of written objections in respect of the application.

Such representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from the 31 July 2015.
