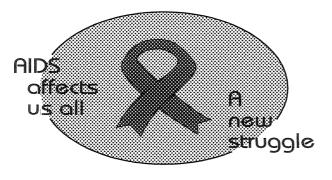

#### AMENDMENTS TO THE GAUTENG GAMBLING REGULATIONS, 2015

#### **Definition**

1. 


