#### APPLICATION FOR AMENDMENT OF BOOKMAKER'S LICENCE

Notice is hereby given that Betting World (Pty) Ltd intend submitting an application to the Gauteng Gambling Board for an amendment of a bookmaker's licence, to relocate from Gold Reef City Casino, corner Northern Parkway and Data Crescent, Ormonde, 2159 to shop 4,5,6, Erf 922 and 923, First Avenue East and Second Avenue East, Geduld, Springs.

- (e) whether or not they wish to make oral representations at the hearing of the application.
