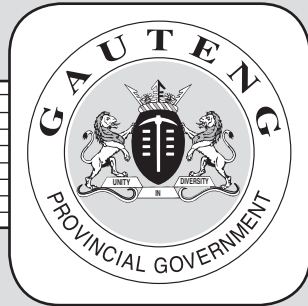

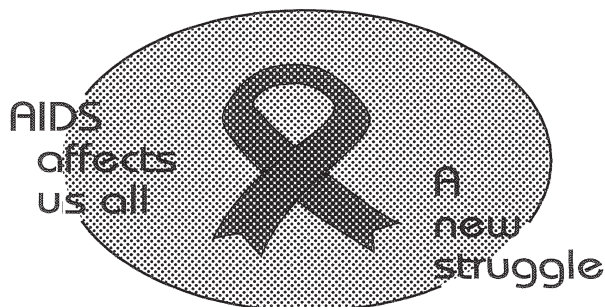

**PROCLAMATION 125 OF 2016****EKURHULENI METROPOLITAN MUNICIPALITY - TEMBISA CUSTOMER CARE CENTRE  
EKURHULENI TOWN PLANNING SCHEME, 2014  
EKURHULENI AMENDMENT SCHEME T0035**

It is hereby notified in terms of section 57(1)(a) of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), that the Ekurhuleni Metropolitan Municipality has approved the amendment of the Ekurhuleni Town Planning Scheme, 2014 by the rezoning of erven 6514-6527 and 6546-6550 from "Residential 1" and "Residential 3" respectively to "Business 1"; Erven 6219 and 6528-6545 from "Residential 3" and "Residential 1" respectively to "Community Facility"; erven 7263-7264, 7266-7270 and 7383 from "Residential 3", "Residential 1" and "Social Services" respectively to "Public Open Space"; erven 6801, (6802, 6981), and (6554-6571, 7252-7261) from "Business 2", "Social Services", and "Residential 3" respectively to "Residential 1"; and erven (6139-6144, 6145-6152, 6153-6168, 7113, 7384-7387), (6172, 6174-6208, 6209-6218, 6220-6256, 6257-6267, 7071-7123, 7171-7190, 7191-7211, 7212-7227, 7271-7280, 7281-7289, 7290-7301, 7302-7307, 7333-7344, 7388-7411, 7412-7438, 7612-7617, 7624-7630, 7657-7684), and 6551 from "Residential 3", "Residential 1" and "Residential 4" respectively to "Residential 4"; Erf 6553 from "Residential 3" to "Social Services" in Clayville Extension 45.

Annexures and scheme clauses of the amendment scheme will be open for inspection during normal office hours at the office of the Manager; City Planning, Tembisa Customer Care Centre, Corner of CR Swart Drive and Pretoria Road, Kempton Park.

This amendment scheme is known as Ekurhuleni Amendment Scheme T0035, and shall come into operation on the date of the proclamation of this notice.
