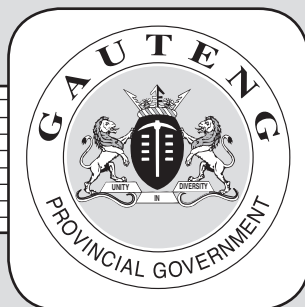



ACT

To provide for the authorisation of certain unauthorised expenditure from the Provincial Revenue Fund; to provide for the non-authorisation of certain unauthorised expenditure; and to provide for matters incidental thereto.

BE IT ENACTED by the Gauteng Provincial Legislature, as follows:—

Authorisation of certain unauthorised expenditure from the Provincial Revenue Fund

1. (1) Expenditure to the amount of R1 802 484 686.90 incurred by the Gauteng Provincial Government during the period April 2004 to March 2006, April 2007 to March 2009 and April 2010 to March 2014, in respect of services rendered by Gauteng Provincial Government and which the Standing Committee on Public Accounts recommended for authorisation by the Legislature, is hereby authorised. 5

(2) The expenditure mentioned in subsection (1) is set out in Schedule 1. 10

(3) The Provincial Revenue Fund is, in terms of section 34(1) of the Public Finance Management Act, 1999 (Act No. 1 of 1999), charged with the expenditure mentioned in subsection (1).

Non-authorisation of certain unauthorised expenditure which becomes the first charge against the funds allocated for the next or future financial years under the relevant vote 15

2. (1) Expenditure to the amount of R8 992 206.00 incurred by the Gauteng Provincial Government during the period April 2011 to March 2012, in respect of services rendered by the Gauteng Provincial Government and which the Standing Committee on Public Accounts recommended for authorisation without funding by Legislature, is hereby authorised without funding. 20

(2) Expenditure to the amount of R13 306 328.06 incurred by the Gauteng Provincial Government during the period April 2008 to March 2009 and April 2011 to March 2012, in respect of services rendered by the Gauteng Provincial Government and which the Standing Committee on Public Accounts did not recommend for authorisation by the Legislature, is hereby not authorised. 25

(3) The expenditure mentioned in subsections (1) and (2) is set out in Schedules 2 and 3, respectively.

(4) The relevant vote is, in terms of section 34(2) of the Public Finance Management Act, 1999 (Act No.1 of 1999), charged with the expenditure on the funds allocated for the next or future financial years under that vote. 30

Short title

3. This Act is called the Gauteng Unauthorised Expenditure Act, 2016.
