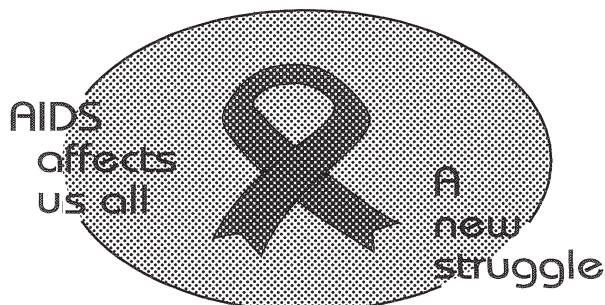

The purpose of this application is to obtain a licence and operate a Totalisator Agency on the premises in the Gauteng Province. The Totalisator Agency Applicant is Mabel Thembeni Mabena t/a Ekangala TAB Agency.

The application will be open for public inspection at the offices of the Board from 23 June 2017.

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act of 1995 (as amended), which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018 or 125 Corlett Drive, Bramley, Johannesburg within one month from 23 June 2017.

Such representations shall contain at least the following information

- (a) The name of the applicant to which representations relate;
- (b) The ground or grounds on which representations are made;
- (c) The name, address, telephone and fax number of the person submitting the representations;
- (d) whether the person submitting the representation request the board to determine that such persons identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to male oral representations at the hearing of the application.
