LOCAL AUTHORITY NOTICE 999 OF 2017**CORRECTION NOTICE / REGSTELLINGSKENNISGEWING**

A. It is hereby notified in terms of Section 60 of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986) that Local Authority Notice 757 which appeared on 24 May 2017, with regard to Erven 138 and 139 Auckland Park is amended as follows :
