The Removal of Condition(s) **(a) to (g) in their entirety** contained in the Deed of Transfer **Nos.T39096/2015 and T39097/2015**, pertaining to **Erven 869 and 871 Orange Grove respectively** and the simultaneous amendment of the Johannesburg Town Planning Scheme, 1979, by the rezoning of the properties described above, situated at **41 and 43 Thirteenth Street, Orange Grove** from **“Residential 1”** and **“Residential 4”** subject to certain conditions in terms of Johannesburg Amendment Scheme No. **13-0500** to **“Residential 4”**, subject to certain amended conditions.
