GAUTENG GAMBLING REGULATIONS, 1997

The Member of the Executive Council responsible for Economic Development, Environment, Agriculture and Rural Development in the Gauteng Province has, in terms of section 84 of the Gauteng Gambling Act, 1995 (Act No. 4 of 1995), made amendments the Regulations set out in the Schedule.

Definition

in these Regulations, unless the context otherwise indicates—


