Notice is hereby given that Sportsbet United (Pty) Ltd from intends submitting an application to the Gauteng Gambling Board for an amendment of a bookmaker's licence to relocate from Shop 1b, Tsakane Mall, Modjadji, Jabulani and Tsakane street, Tsakane, Brakpan to Tsakane Square, cnr Tsakane and Jabulani streets, Tsakane. My application will be open to public inspection at the offices of the Board 10 April 2017.

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act, 1995 which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018 or 125 Corlett Drive, Bramley, Johannesburg, within one month from 10 April 2017.

Such representation shall contain at least the following information:

- (a) The name of the applicant to which representations relate;
- (b) The ground or grounds on which representations are made;
- (c) The name, address, telephone and fax number of the person submitting the representations;
- (d) Whether the person submitting the representations requests the board to determine that such person's identify may not be divulged and the grounds for such request; and
- (e) Whether or not they wish to make oral representations at the hearing of the application.
