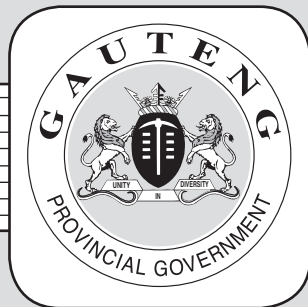

**LOCAL AUTHORITY NOTICE 222 OF 2018****LOCAL AUTHORITY NOTICE T004****CORRECTION NOTICE****AMENDMENT SCHEME NO 05-12288/1**

It is hereby notified in terms of Section 60 of the Town Planning and Township Ordinance, 1986 (Ordinance 15 of 1986) that the Local Authority Notice Number 1687 which appeared on 8 November 2017 with regard to the Township **Wilgeheuwel Extension 60**, is herewith amended as follows:

**“3 CONDITION OF TITLE****(2) ALL ERVEN**

*The erven shall not be transferred without the written consent of the local authority first having been obtained and the local authority shall have an absolute discretion to withhold such consent, unless the transferee accepts the following condition : the local authority had limited the electricity supply to the erven to **600kVA** and should the registered owners of the erven exceed the supply or should an application to exceed such supply be submitted to the local authority, additional electrical contributions as determined by the local authority, shall become due and payable by such owner/s to the local authority.”*
