LOCAL AUTHORITY NOTICE 1457 OF 2018**CORRECTION NOTICE****CITY OF TSHWANE METROPOLITAN MUNICIPALITY
HEALTH BYLAWS RELATING TO THE KEEPING OF ANIMALS, BIRDS AND POULTRY**

The City of Tshwane Metropolitan Municipality hereby in terms of section 7(4) of the (Gauteng) Rationalisation of Local Government Affairs Act, 1998 (Act 10 of 1998), gives notice of the correction of the City of Tshwane Metropolitan Municipality: Health Bylaws for Keeping of Animals, Birds and Poultry published under Local Authority Notice 1589 in the Gauteng Provincial Gazette No 242; Vol. 23 dated 4 October 2017.

The general purport of the correction is the amendment of Section 3(3) of the said By-law dealing with the Application of the By-Laws as well as the amendment of Section 5(c) and (d) dealing with Premises for the Keeping of Animals, Birds and Poultry.

Sub-section (3) of Section 3 which read as follows:

[Sections 4, 5, 6, 8, 10, 12, 14, 16, 18, 19 and 21 are not applicable on residential premises and on property zoned residential as prohibited by the general provisions of these bylaws]

is hereby deleted and substituted with the following wording hereunder as underlined:-

(3) Sections 4, 6, 8, 10, 12, 14, 16, 18, 19 and 21 are not applicable on residential premises and on property zoned residential as prohibited by the general provisions of these bylaws;

Paragraphs (c) and (d) of section 5 which read as follows:

[(c) keep more than 10 units of poultry or 10 rabbits or 10 birds on residential premises, provided that more than 10 units of poultry may be kept on an agricultural holding and that the owner, occupier or keeper ensures that no health nuisance is constituted;

(d) keep more than three (3) dogs or three (3) cats older than six (6) months on property zoned residential;]

is hereby deleted and substituted with the following wording hereunder as underlined:-

(c) keep more than 10 (ten) units of poultry or 10 (ten) rabbits or 10 (ten) birds, the maximum number of any of these classes of animals, jointly not exceeding 10 (ten) in number on a residential premises, provided that more than 10 units of poultry may be kept on an agricultural holding and that the owner, occupier or keeper ensures that no health nuisance is constituted

(d) keep more than three (3) dogs or three (3) cats older than six (6) months, the maximum number of any of these animals, jointly not exceeding 3 (three) in number, on property zoned as residential
