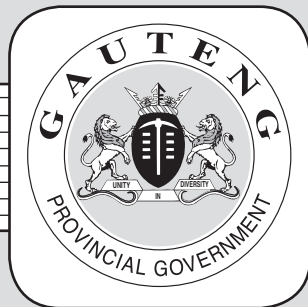

**Notice of request for public comments for the amendment of Emergency Services By-Laws of the City of Johannesburg**

The Council hereby gives notice that it intends to amend the Emergency Services By-laws in terms of section 7(5) of the Rationalisation of Local Government Affairs Act, No 10 of 1998.

**The purport of the amendments is to:**

- Introduce additional definitions in the by-laws
- Delete certain provisions/phrases relating to the by-laws
- Make addition to certain expressions in the by-laws
- Include provisions relating to:
  - Submission of fire protection plans
  - Installation and maintenance of firefighting equipment
  - Structures at public gatherings

Any organisation or person who wishes to comment and make contributions to the by-laws is hereby invited to do so. The public has 30 days for commenting from the date of this advert until close of business on **13 December 2018**.
