

TRANSFER OF POWERS AND FUNCTIONS ENTRUSTED BY SECTION 4(5)(a) OF THE GOVERNMENT IMMOVABLE ASSET MANAGEMENT ACT, 2007, IN TERMS OF SECTION 137 READ WITH SECTION 140 OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996

I, Malemolla David Makhura, Premier of the Province of Gauteng, by virtue of the powers vested in me under section 137 read with section 140 of the Constitution of the Republic of South Africa, 1996, hereby transfer to the Department of Infrastructure Development, which is the custodian of all immovable assets that vest in the Gauteng Provincial Government pursuant to section 4(1)(c) read with the definition of "custodian" in section 1 of the Government Immovable Asset Management Act, 2007 (Act No. 19 of 2007), the powers and functions entrusted to a user department by section 4(5)(a) of that Act, as a custodian in the case of a public private partnership relating to an immovable asset.

This transfer commences from 5 February 2019 and will remain in force for the duration of the public private partnership concession agreement for the Kopanong Precinct Project.
