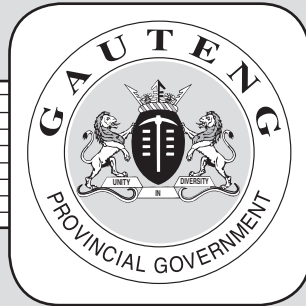

I, Mirna Ann Mulder of MM Town Planning Services, being the applicant of the property namely **ERF 244 GRACEVIEW EXTENSION 3, MIDVAAL**, hereby give notice in terms of Section 38 and Section 51 of the Midvaal Local Municipality Spatial Planning and Land Use Management By-Law, 2018, that I have applied to Midvaal Local Municipality for a change of Land Use Rights also known as a Rezoning with a Simultaneous Subdivision application on the property described above. The property is situated to the west of the R59 in the Township of Graceview Extension 3, Kliprivier Business Park, south of the interchange of the R550.

The proposed **rezoning** is from "**Industrial 1**" to "**Utilities**".

The proposed **subdivision** is to subdivide the property into five (5) portions of 15,032ha, 20,0065ha, 0,1303ha, 0,1340ha and 39,6496ha. Total 74,9546ha in extent.
