It is hereby notified in terms of the provisions of Section 80 of the Town-planning and Townships Ordinance, 1986 (Ordinance No 15 of 1986), that Local Authority Notice 237 of 2018 in the Gauteng Provincial Gazette No 24, dated 7 February 2018, with regard to Bronberg Extension 25, is hereby rectified as follows:

Paragraph 1.16 should be deleted in toto:

**“1.16 NOTARIALLY TIE OF ERVEN**

The township owner shall at his own expense have Erf 660 and Erf 661 notarially tied as he wish to open a Sectional title Register and that the building or buildings to be divided into sections shall be situated on two or more contiguous pieces of land registered in the name of the township owner.”

Substitute the expression:

**“4.2.6 ERVEN 660 AND 662**

The erven shall be entitled to a right of way servitude 3m wide represented by the figure b q p n m r s t u v b over Erf 661 as indicated on the General Plan SG No 1605/2016. ERVEN 660 AND 661

The erven are subject to the following conditions in favour of the Non-Profit Company (Homeowner's Association) to be created on transfer of the erven to any purchaser.”

with the expression:

**“4.2.6 ERVEN 660 AND 662**

The erven shall be entitled to a right of way servitude 3m wide represented by the figure b q p n m r s t u v b over Erf 661 as indicated on the General Plan SG No 1605/2016.

**4.2.7 ERVEN 660 AND 661**

The erven are subject to the following conditions in favour of the Non-Profit Company (Homeowner's Association) to be created on transfer of the erven to any purchaser.”
