NOTICE 1041 OF 2020**CORRECTION NOTICE**

The City of Johannesburg Metropolitan Municipality herewith gives notice in terms of the provisions of Section 80 of the Town Planning and Townships Ordinance, 1986, as amended, that Local Authority Notice 67 dated 13 March 2015 in respect of Laser Park extension 36, has been amended as follows:

A. THE ENGLISH NOTICE:

By the substitution of clause (2) with the following:

(2) ALL ERVEN

The erven shall not be transferred without the written consent of the local authority first having been obtained and the local authority shall have an absolute discretion to withhold such consent, unless the transferee accepts the following condition: The local authority had limited the electricity supply to the erven to 315 kVA and should the registered owners of the erven exceed the supply or should an application to exceed such supply be submitted to the local authority, additional electrical contributions as determined by the local authority, shall become due and payable by such owner/s to the local authority.

B. THE AFRIKAANS NOTICE:**(2) ALLE ERWE**

Die erwe sal nie oorgedra word sonder dat die skriftelike toestemming van die plaaslike owerheid eers verkry is nie, en die plaaslike owerheid het 'n absolute diskresie om sodanige toestemming te weerhou, tensy die oordraer die volgende voorwaarde aanvaar: Die plaaslike owerheid het die elektrisiteitstoever tot die erwe tot 315 kVA en indien die geregistreerde eienaars van die erwe die toevoer oorskry, of indien 'n aansoek om sodanige toevoer te oorskry by die plaaslike bestuur ingedien word, sal addisionele elektriese bydraes soos deur die plaaslike owerheid bepaal, verskuldig en betaalbaar wees deur sodanige eienaar / s. aan die plaaslike owerheid.
