It is hereby notified in terms of Section 46(4) of the Mogale City Local Municipality Spatial Planning and Land Use Management By-Law, 2018 that Mogale City Local Municipality approved the amendment of the Krugersdorp Town Planning Scheme, 1980, by the rezoning of Holding 10 Diswilmar Agricultural Holdings, from "Agricultural" to "Agricultural" to accommodate an Institution and the Expansion for a Private Higher Education Facility and Administrative Head Office" and related uses subject to conditions in terms of Section 45 of the Mogale City Spatial Planning and Land Use Management By-Law, 2018.

Copies of the application as approved are filed with the offices of the Municipal Manager of the Mogale City Local Municipality and are open for inspection at all reasonable times.

This amendment scheme is known as the Krugersdorp Amendment Scheme 1898 and shall come into operation on the date of publication hereof.
