 Proposed Development Controls: The township will consist of 92 erven in total.

Twenty-five (25) "Residential 3 Erven" with a density of 160 units per hectare and a height of 4 storeys.

Twenty-eight (28) "Business 1 Erven" with a coverage of 90% and FSR of 3.6 and a height of 2 storeys.

Nineteen (19) "Institutional Erven" with a coverage of 70% and FSR of 2.1 and a height of 3 storevs.

Four (4) "Educational Erven with a coverage of 70% and FSR of 2.1 and a height of 3 storeys.
