The Member of the Executive Council responsible for local government in the Province of Gauteng, after consultation with the Municipalities of the City of Johannesburg, City of Tshwane, City of Ekurhuleni, Sedibeng District (including the Local Municipalities of Lesedi, Emfuleni and Midvaal) and the West Rand District (including the Local Municipalities of Merafong City, Rand West City and Mogale City), and organised local government in the Province of Gauteng, gives notice as required in terms of section 16(3)(c) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), as amended, of the publication of particulars of proposed notices amending the Notices that established the abovementioned municipalities for public comment.

The proposed amendment Notices makes provision for the determination of the number of councillors that each municipal council will consist of following the local government elections proclaimed for 1 November 2021. The amendment Notices further makes provision for new boundary determinations to effect technical changes and does not have a material impact on the municipalities affected by same. The new boundary determinations affect the boundaries of all the municipalities in the Province, except the Municipalities of the City of Tshwane, Lesedi and Rand West City.
