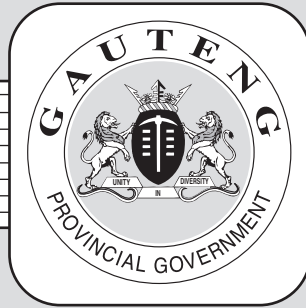

Notice is hereby given that Phumelela Gaming and Leisure Limited t/a TAB of No 14 Turf Club Street, Turffontein, 2190 intend submitting an application to the Gauteng Gambling Board for appointment of a new TAB Agent for the following site:

1. Shop No 12B, Proteapoint Shopping Centre, ERF 2567, Ndaba Drive, Protea North, Soweto, Gauteng Province

The purpose of this application is to obtain the TAB Agency license and operate a Totalisator Agency at the abovementioned premises in Gauteng Province. The proposed Agent is Masilo Rock Construction CC t/a Proteapoint TAB Agency and represented by Director, Phillip Vamu Masilo.

Applications will be open to public inspection at the offices of the Board from 20 October 2021. Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act No 4 of 1995 (as amended) which makes provision for the lodging of written representations in respect of the application. Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018 or 125 Corlett Drive, Bramley, Johannesburg within one month from 20 October 2021.

Such representations shall contain at least the following information:

- (a) The name of the applicant to which representations relate
- (b) The ground or grounds on which representations are made
- (c) The name, address, telephone, email or fax number of the person submitting the representations.
- (d) Whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) Whether or not they wish to make oral representations at the hearing of the application.
