Act No. 1 of 2007

LIMPOPO ADJUSTMENTS APPROPRIATION AMENDMENT ACT, 2007

ACT

To amend the Limpopo Adjustments Appropriation 2006/07 Act and Schedule thereof which appropriated an adjusted amount of money for the requirements of the Province in respect of the financial year ending 31 March 2007, and to provide for matters incidental thereto.

BE IT ENACTED by the Legislature of the Province of Limpopo, as follows:

Appropriation of adjusted amounts of money for requirements of the Province

1. Subject to the provisions of the Public Finance Management Act, (Act 1 of 1999) as amended by (Act 29 of 1999), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province, in respect of the financial year ending 31 March 2007, as a charge to the Provincial Revenue Fund, the adjusted amounts of money shown in the amended Schedule.

Amendment of the Schedule

2. The Schedule to this Bill is hereby substituted for the Schedule of the Limpopo Adjustments Appropriation Act, 2006/07.

Short title

3. This Act shall be called the Limpopo Adjustments Appropriation Amendment Act, 2007.




