RENTAL HOUSING ACT, 1999 (ACT 50 OF 1999)


CALL FOR NOMINATIONS TO SERVE ON THE LIMPOPO RENTAL HOUSING TRIBUNAL

1. In terms of section 7 and 9(2)(a) of the Rental Housing Act 50 of 1999, the Member of the Executive Council responsible for Local Government and Housing in the Limpopo Province, hereby invites nominations of persons as candidates for the respective positions of the Limpopo Rental Housing Tribunal.
2. The Limpopo Rental Housing Tribunal shall consist of not less than three and not more than five members, who are fit and proper persons appointed by the Member of the Executive Council; and must comprise -
 - a. a person, who is suitably qualified and has the necessary expertise and exposure to rental housing matters,
 - b. persons with expertise in property management or housing development matters; and
 - c. persons with expertise in consumer matters pertaining to rental housing and housing development matters.
3. The tribunal must fulfil the duties imposed upon it in terms of Chapter 4 of the Rental Housing Act, 1999 (Act 50 of 1999) and must do all the things necessary to ensure that the objectives of Chapter 4 are achieved.
