NEGOTIATION OF ARRANGEMENT IN TERMS OF SECTION 11 (1) (b) OF THE CONSUMER AFFAIRS (UNFAIR BUSINESS PRACTICE) ACT 8 OF 1996 AS AMENDED

Whereas GRIETA TLADI (the complainant) ID:5311110216088 paid an amount of **R10700,00 (Ten thousand seven hundred rand)** in monthly instalment to LIMPOPO GRANITE to erect a tombstone at **MARATAPELO GA CHUENE** grave yard.


Whereas the respondent **JACOB MARTHINUS VAN RENSBURG, ID: 6008195026080** trading as **LIMPOPO GRANITE** acknowledge receipt of the aforesaid mentioned amount.

Whereas the respondent agreed to erect the tombstone at **MARATAPELO GA CHUENE** village a week before the **8th October 2005**.

Whereas the respondent breached the agreement by erecting a different tombstone from which the applicant selected in **Limpopo Granite photo albums**, with changes as agreed with the respondent.

WHEREAS the complainant lodged a complaint of unfair business practice against the Respondent with the office of the Consumer Protector of Limpopo Province.

AND WHEREAS this arrangement subject to the Limpopo Consumer Affairs Court confirming it, has the effect of an order of the Court by publication in the Limpopo Provincial Government Gazette;

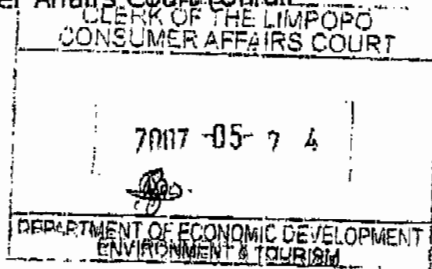
The respondent notes the complaint and the consent that he was supposed to erect the agreed tombstone on a week before the unveiling and has failed to erect the tombstone. NOW THEREFORE THE PARTIES AGREE AS FOLLOWS SUBJECT TO CONFIRMATION BY THE COURT IN TERMS OF SECTION 21 OF THE ACT:

- 1. That JACOB MARTHINUS VAN RENSBURG trading as Limpopo Granite will refund the capital amount of **R10700,00 (ten thousand seven hundred rand)** in three instalments as follows:

1st instalment of **R4000.00 (four thousand rand)**, to be effected on or before 31 May 2007. 2nd instalment of **R4000.00 (four thousand rand)** to be effected on or before 30 June 2007 and the balance of **R7089.34 (seven thousand and eighty nine rand thirty four cent)** with interest to be effected on or before the 07 August 2007.

- 2. In addition to the capital, Interest at the prescribed rated of 15, 5% of R4389.34 calculated from 13/12/2004 to date of final payment, and that amount has been included in the final instalment
- 3. The aforesaid amount shall be paid to the complaint account number **133721736 at Standard Bank Polokwane Branch.**

The Office hereby applies to the court for an order confirming this agreement in terms of section 21 of the Consumer Affairs Court (Unfair Business Practices Act) 8 of 1996
