APPOINTMENT OF THE FOLLOWING POST OFFICES: BELA-BELA, BURGERSFORT, GIYANI, LEBOWAKGOMO, LEPHALALE, MARBLE HALL, MODIMOLLE, MPUDULLE NORTH, MUSINA, POLOKWANE NORTH, THABAZIMBI AND TSHIKONDENI AS REGISTERING AUTHORITIES IN TERMS OF SECTION 2 OF THE NATIONAL ROAD TRAFFIC ACT, 1989 (ACT 29 OF 1989).MS OF SECTION 2 OF THE ROAD TRAFFIC ACT, 1989 (ACT 29 OF 1989)

I, **Pinky Kekana**, Member of the Executive (**MEC**) for Roads and Transport, by notice in the Provincial Gazette, appoints the abovementioned Post Offices as Provincial Registering Authorities in terms of Section 2 of the Road Traffic Act, 1989 (Act 29 of 1989).

The powers and duties conferred or imposed upon the appointed Registering Authority by or under this Act shall be exercised or performed on behalf of the said registering authority by the person authorized thereto by the registering authority.

The Registering Authority shall undertake to perform the functions conferred upon them in accordance with the provisions and in terms of the requirements of the Roads Traffic Act, 1989 (Act 29 of 1989), and the regulations framed there under: but in addition, also in terms of such directives as may be issued by the Provincial Administration, the functions thereof shall revert to the Provincial Administration.
