And applicable rebates will apply as per Ba-Phalaborwa Municipality's Property Rates Policy.

In terms of section 29 (1), the amount due for rates will be payable in 12 (twelve) equal monthly installments on the following dates.

June 2011	27 June 2011

Interest will be levied on all amounts in arrears and defaulters are subject to legal proceedings for recovery of such arrears and will be liable such costs in terms of municipality's Credit Control and debt collection by-law.
