


I Pinky Kekana, Member of the Executive Council for Roads and Transport Limpopo Province, hereby give notice in terms of Section 48 Sub-sections (1), (2), (3), (4), (5), (6), (7) and (8) of the Northern Province Roads Agency (Pty) Limited and Provincial Roads Act, 1998 Act No 7 of 1998, for the erection of two manned control gates for on a portion of road D598 (Mookgophong road) in the Waterberg district at KM 73,277 (GPS LAT S 24°19'03,3" LONG E 28°42'21,4") and at KM 82,583 (GPS LAT S 24°14'17,8" LONG E 28°43'33,7") on conditions that no member of the public will be denied access of using the road, the gates be manned 24 hours a day, two additional gates for agricultural machines be erected and that pedestrians shall be transported between the two gates.


