**PROVINCIAL NOTICE****No. 5****8 August 2011****DISSOLUTION OF LIMPOPO AGRIBUSINESS DEVELOPMENT CORPORATION BOARD**

By virtue of the Powers vested in me in terms of Section 8 (2) of the Northern Transvaal Corporation Act, 1994(Act No.5 of 1994) I Dipuo Letsatsi-Duba, member of the Executive Council for Agriculture hereby dissolves the Limpopo Agribusiness Development Board to give effect to the Executive Council Decision 156/2010 read with Executive Council Decision 61/2007 and 50 /2010 for establishment of a Single Economic Development Agency.

The Limpopo Agribusiness Development Corporation Board was dissolved at its special meeting held on the 28 January 2011 (Resolution No.28/01/2011) to make way for the Interim Board of the Envisaged Single Economic Development Agency which assumed its duties on the 1<sup>st</sup> April 2011.
