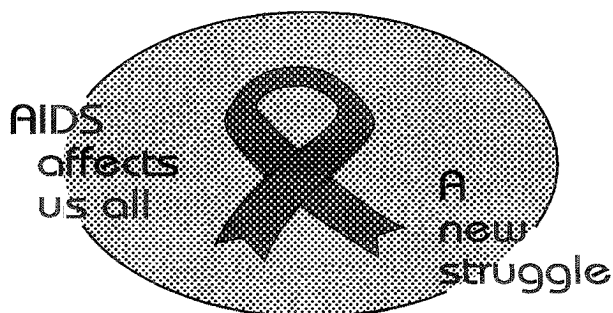

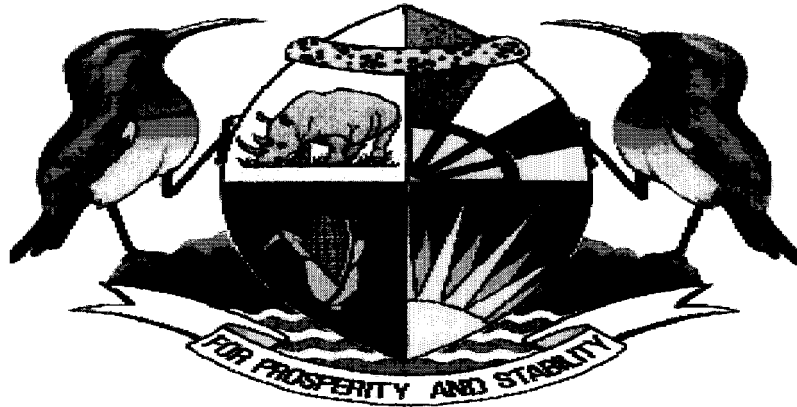

### AMENDMENT OF LIMPOPO PROVINCIAL GAZETTE NUMBER 2054 DATED 15 MARCH 2012

The Municipal Manager of Waterberg District Municipality hereby amend Limpopo Provincial Extraordinary Gazette number 2054 by inserting annexure "iv" in the by-law

#### ANNEXURE IV

#### **1. Material Safety Data Sheet Box and Emergency Evacuation Plan Box [MSDS Box]**

- i. A container no smaller than 300 x 400 mm shall be provided to contain all MSDS's;
- ii. Material safety data must be provided for every individual chemical substance when such substance is to be found on the said premises and falls outside exempt quantities as described in SABS 0228;
- iii. Such MSDS shall contain no less information than shown on NOSA Form 2.17.05.01 "Hazardous Substances Record";
- iv. Such container shall be affixed to the outside of the building next to or near the main entrance and shall be placed 1,5 m above ground level; and
- v. Such container shall have a locking device which will be to the satisfaction of the Chief Fire Officer.

#### **2. Emergency Evacuation Plan Box [EEP Box]**

- i. A container no smaller than 300 x 400 mm shall be provided to contain all EEP's;
  - ii. Such container shall have a locking device which will be to the satisfaction of the Chief Fire Officer;
  - iii. Such container shall be painted dayglow orange and be marked in black capital letters no smaller than 150 x 15 mm and shall read 'EEP' EMM Emergency Services By-laws
