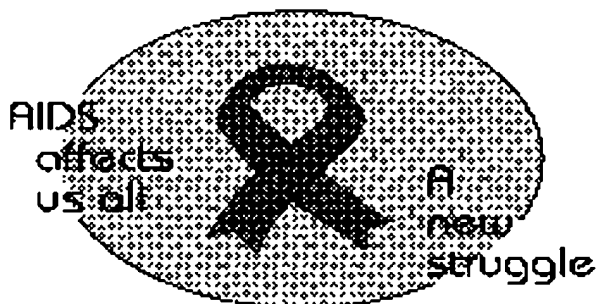



ROADS & TRANSPORT****NOTICE TO PRESCRIBE EXTRAORDINARY MEASURES IN TERMS OF SECTION 91(1) OF THE NATIONAL LAND TRANSPORT ACT 2009**

I, Pitsi Moloto, Member of Executive Council in Limpopo responsible for Roads and Transport, prescribe in terms of section 91(1) read with section 10(1)(a) and (b) of the National Land Transport Act 2009, Act 5, 2009 and section 55 of the Northern Province Interim Passenger Transport Act 2000 as amended, extraordinary measures in the area under the Maruleng Local Municipality and specific routes travelled by Letaba and The Oaks taxi associations as follows:

- a) all the routes travelled by licensed vehicles of Letaba and The Oaks taxi associations and the taxi ranks in Maruleng Local Municipality are closed for minibus-type taxi service with immediate effect for the period up to 30 November 2012 or until such time a solution to the conflict is implemented, whichever comes first;
- b) all the operating licenses issued to members of Letaba and The Oaks taxi associations are suspended for the duration of the validity of this notice;
- c) no person may undertake minibus-type taxi service on the taxi ranks and routes declared closed in paragraph (a) above;
- d) temporary operating licenses will be issued to vehicles with a sitting capacity of more than 17 to render public transport services in the area affected by this notice;
- e) anyone who contravenes or fail to comply with this notice commits an offence and may face penalties ranging from a fine to an imprisonment not exceeding six months;
- f) law enforcement officers will monitor the affected area at all times during the period of the validity of this notice;
- g) the MEC may by notice in the *Provincial Gazette* and at any time amend this notification.
