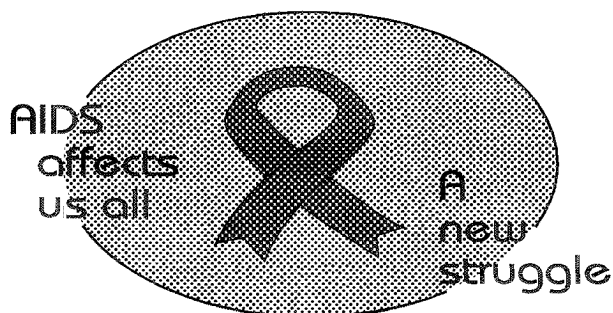

### NOTICE 372 OF 2012

#### NOTICE FOR THE APPOINTMENT OF CANDIDATES TO SERVE AS MEMBERS OF THE MPUMALANGA HERITAGE RESOURCES COUNCIL

The MEC for Culture, Sport & Recreation in Mpumalanga Province has in terms of section 23 of the National Heritage Resources Act No.25 of 1999, ("the Act") established a body corporate known as the Mpumalanga Heritage Resources Authority. This Authority is responsible for the management of heritage resources in the Province.

The Mpumalanga Heritage Resources Authority shall be governed by a Council known as the Mpumalanga Heritage Resources Authority Council. The members of the Council shall be appointed on a part –time (three year contract) basis on account of their competence, experience and interest in the field of heritage.

The functions of Council are as prescribed in terms of Regulations issued in the Provincial Gazette.

The MEC calls for public nominations of people who will serve in the Mpumalanga Heritage Resources Authority Council. Such nominees need to be knowledgeable in the fields of archaeology, heritage, conservation, human and social sciences, folklore, law and management. Nominees must also have commitment to the preservation of the collective heritage and should not hold office in any political party. Members of the Council will not receive salaries but will be reimbursed for expenses associated with serving in the Council.

Anyone wishing to nominate a candidate should adhere to the following requirements:

- Submit a letter containing the full names, address, telephone, and fax and email address of the nominee.
- Give reasons for nominating such candidate.
- Submit a detailed CV of the nominee with at least three contactable referees.
- A brief statement signed by the nominee in which he/ she agrees to be nominated

No nominations will be considered unless the above requirements are adhered to.
