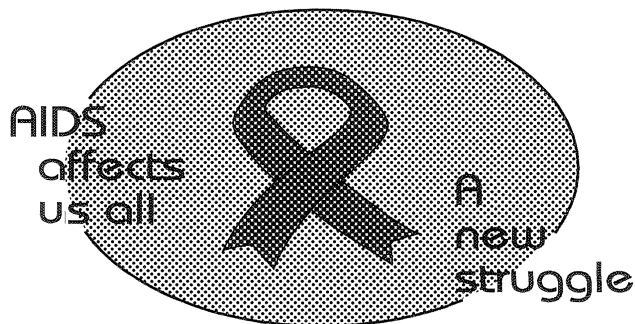

#### ELECTRICITY BY-LAWS

Notice is hereby given that the Makhado Municipality amends the contents of its Notice No 80 of 2012 dated 29 June 2012, which was promulgated in the Limpopo Provincial Gazette No 2096 dated 11 July 2011 under Local Authority Notice No 129 of 22 July 2011, by correcting the contents of paragraph 3.3.13 and only that paragraph to the extent of the actual tariffs as recorded, to read as follows:
