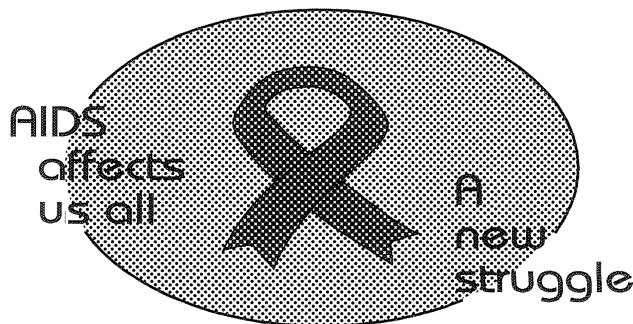

Notice is hereby given in terms of Section 49(1) (a) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), hereinafter referred to as the "Act", that the 2<sup>nd</sup> Supplementary Valuation Roll for the financial year 2012/2013 in terms of Section 78 of the Act is open for public inspection at the **Municipal Library, 64 Springbok Street, Hoedspruit, 1380**, during normal office hours (08H00 to 16H00) or on Municipal Website ([www.maruleng.gov.za](http://www.maruleng.gov.za)) for a period of 35 days starting from the 24<sup>th</sup> May 2013 until the 25<sup>th</sup> June 2013.
