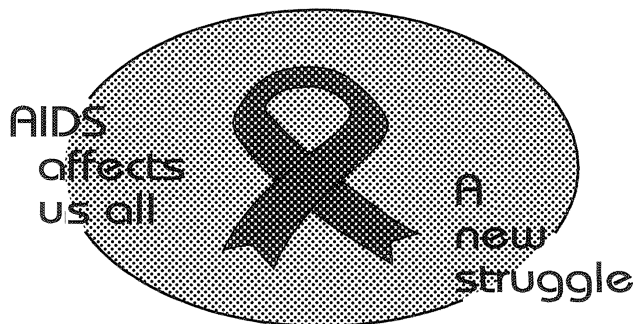

## LOCAL AUTHORITY NOTICES

### LOCAL AUTHORITY NOTICE 123

### BY-LAW

To provide for the implementation and enforcement by the Mookgophong Local Municipality of its policies regarding tariffs and for matters connected therewith.

#### Preamble

Whereas section 75 of the Municipal Systems Act, 2000 (No. 32 of 2000) as amended, provides that a municipal council must adopt by-laws to give effect to the implementation and enforcement of its tariff policy and that it may differentiate between different categories of users, debtors, service providers, services, service standards and geographical areas as long as such differentiation does not amount to unfair discrimination.

**BE IT ENACTED** by the Mookgophong Local Municipality, as follows:-

#### Definitions

1. In this By-law, unless the context otherwise indicates -

“**Municipality**” means the Mookgophong Local Municipality / Council; and

“**the Act**” means the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000).

#### Implementation of the policy

2. (1) The Municipality must, subject to section 3 and any national or provincial legislation regulating local government finance, give effect to its tariff policy;
- (2) draft and adopt in accordance with sections 74 of the Act, respectively, by implementing and enforcing such policies;
- (3) Any person who lays claim to a rebate or concession under a policy referred to in subsection (1), must provide the information required and meet the obligations imposed by such policy;
- (4) The Municipality shall not be entitled to levy tariffs other than in terms of its tariff policy.

#### Publication of the policy

3. A policy referred to in section 2 and any amendment thereto must be published in the *Provincial Gazette*.

#### Enforcement of the Tariff Policy

4. The Municipality's Tariff Policy shall be enforced through the Credit Control and Debt Collection By-law and Policy and any further enforcement mechanisms stipulated in the Act and the Municipality's Tariff Policy.

#### Short title and commencement

5. This By-law shall be called the Tariffs By-law, and takes effect on 1 July 2013

**LOCAL AUTHORITY NOTICE 124****BY-LAW**

To provide for the implementation and enforcement by the Mookgophong Local Municipality of its policies regarding debt collection and credit control and for matters connected therewith.

**Preamble**

Whereas section 98 of the Municipal Systems Act, 2000 (No. 32 of 2000) as amended, provides that a municipal council must adopt by-laws to give effect to the municipality's credit control and debt collection policy, its implementation and enforcement and that it may differentiate between different categories of ratepayers, users of services, debtors, taxes, services, service standards and other matters as long as the differentiation does not amount to unfair discrimination.

**BE IT ENACTED** by the Mookgophong Local Municipality, as follows:-

**Definitions**

1. In this By-law, unless the context otherwise indicates -

“**Municipality**” means the Mookgophong Local Municipality / Council; and

“**the Act**” means the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000).

**Implementation of the policy**

2. (1) The Municipality must, subject to section 3 and any national or provincial legislation regulating local government finance, give effect to its tariff policy;
- (2) draft and adopt in accordance with sections 98 of the Act, respectively, by implementing and enforcing such policies;
- (3) Any person who lays claim to a rebate or concession under a policy referred to in subsection (1), must provide the information required and meet the obligations imposed by such policy;
- (4) The Municipality shall not be entitled to levy tariffs or penalties other than in terms of its tariff policy.

**Publication of the policy**

3. A policy referred to in section 2 and any amendment thereto must be published in the *Provincial Gazette*.

**Enforcement of the Debt Collection and Credit Control Policy**

4. The Municipality's Credit Control and Debt Collection Policy shall be enforced through the By-law and any further enforcement mechanisms stipulated in the Act.

**Short title and commencement**

5. This By-law shall be called the Credit Control and Debt Collection By-law, and takes effect on 1 July 2013

**LOCAL AUTHORITY NOTICE 125****BY-LAW**

To provide for the implementation and enforcement by the Mookgophong Local Municipality of its policies regarding property rates and for matters connected therewith.

**Preamble**

Whereas section 6 of the Local Government Municipal Property Rates Act, 2004 (No.6 of 2004) as amended, provides that a municipality must adopt by-laws to give effect to the implementation of its rates policy and that it may differentiate between different categories of properties; and different categories of owners of properties liable for the payment of rates.

**BE IT ENACTED** by the Mookgophong Local Municipality, as follows:-

**Definitions**

1. In this By-law, unless the context otherwise indicates -

“**Municipality**” means the Mookgophong Local Municipality / Council; and

“**the Act**” means the Local Government: Municipal Property Rates Act, 2004 (No 6 of 2004).

**Implementation of the policy**

2. This policy shall :

- (1) Apply to all rates levied by the Municipality pursuant to the adoption of its annual budget;
- (2) Comply with the requirements for:
  - (a) the adoption and contents of a rates policy specified in section 3 of the Act;
  - (b) the process of community participation specified in section 4 of the Act; and
  - (c) the annual review of a rates policy specified in section 5 of the Act.
- (3) Specify any further principles, criteria and implementation measures consistent with the Act for levying of rates which the Municipality may adopt; and;
- (4) Include such further enforcement mechanisms, if any, as the Municipality may wish to impose.

**Publication of policies**

3. A policy referred to in section 2 and any amendment thereto must be published in the *Provincial Gazette*.

**Enforcement of the Tariff Policy**

4. The Municipality's Property Rates Policy shall be enforced through the Credit Control and Debt Collection By-law and Policy and any further enforcement mechanisms stipulated in the Act.

**Short title and commencement**

5. This By-law shall be called the Property Rates By-Law, and takes effect on 1 July 2013.
