Notice is hereby given in terms of the provisions of Section 24, 2(a) (b) of the Limpopo Gambling Act of 1996, as amended, that Phumelela Gaming and Leisure has made an application for amendment of a Totalisator licence for the establishment of a new outlet at Shop 17, Malamulele Crossing, Portion 1 of ERF 1 Malamulele A.

The application will lay for public viewing for 30 (thirty) days at the offices of the Limpopo Gambling Board; on 01 November 2013 at No 08 Hans Van Rensburg Street, Polokwane, 0700, Limpopo.
