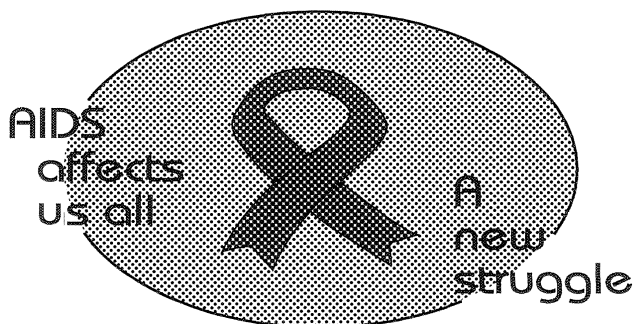

GENERAL NOTICE OF JOINT DISTRICT MUNICIPAL TRIBUNAL BY AGANANG LOCAL MUNICIPALITY
