**BA-PHALABORWA LOCAL MUNICIPALITY**

**PUBLISHED IN TERMS OF CHAPTER 4 OF THE LOCAL GOVERNMENT MUNICIPAL SYSTEMS ACT, 2000 (ACT 32 OF 2000) READ TOGETHER WITH SECTION 20 OF THE SPATIAL PLANNING AND LAND USE MANAGEMENT ACT, 2013 (ACT 16 OF 2013) FOR THE REVIEW OF BA-PHALABORWA LOCAL MUNICIPALITY SPATIAL DEVELOPMENT FRAMEWORK.**

In terms of the provisions of Sections 20 of the Spatial Planning and Land Use Management Act, 2013 (Act 16 of 2013) read together with Section 16 of Local Government: Municipal Systems Act, 2000 (Act 32 of 2000 as amended), a municipality must compile a Municipal Spatial Development Framework (MSDF) and review or amend it thereof. Ba-Phalaborwa Local Municipality SDF, 2009 forms an integral part of Ba-Phalaborwa Integrated Development Plan.

It is therefore the intention of Ba-Phalaborwa Local Municipality to review the SDF, 2009 and will appoint a service provider for this purpose. The provisions of applicable legislations requires that the municipality must through appropriate mechanisms, processes and procedures consult the local community before adopting the final MSDF. Relevant stakeholders and interested and affected parties are requested to register to take part in the process by registering as an interested and or affected party.
